The Wright County Fair is looking forward to produce an excellent auction; However, The Wright County Ag Society & Fogarty Auction Service will NOT responsible for accident, injury, theft, or damage.

This sale is limited to Donkeys, Mules, Hinny, & Mares bred to Jacks.
All breeding Jacks must have 2 handlers (for safety reasons).

All Equipment & Tack **must** be Donkey &/or Mule related.

Animals will be sold to the highest bidder; all sales are final.

All animals **MUST** have negative Coggins Test;
and all out of State animals **MUST** have Health Papers!

Only sale animals may be in or around the sale area.

We reserve the right to **REFUSE** any tack or animals.

Our goal is to provide a quality sale, **PLEASE** don't bring any unsound animals.

There is **NO** warranty of any kind to the soundness or condition of any animal.

There are **NO** guarantees of pregnancy status unless made known by consignor.

Pass-out fee or No-Sale fee are the same. They must be paid with the stalling fee before the sale.

A release of animals or tack will **NOT** be allowed until buyer pays **IN-FULL**.

All stalls must be cleaned out before leaving the Fairgrounds;
All sale animals must vacate the Fairgrounds Sunday evening unless arrangements have been made with the managers.

Good quality halter and lead rope must be provided with the animal.

Animals shall belong to the buyer when leaving the sale area.

Consignor shall be obligated to return animal to the proper stall.

For Security purposes Tack & Equipment will be accepted
8am – 11am Sunday (day of sale).

Buyers and Spectators must use extreme caution while on the Fairgrounds particularly around animals being shown or at the auction sale; The Wright County Fair & Fogarty Auction Service is **NOT** responsible for Damage or accidents!

Before unloading of the animals, a stalling representative must be present and current Coggins test supplied, and all out of state animals **MUST** have health papers!

Tack dealers must be pre-approved prior to the sale; Consignors are limited up to 12 tack items or less. (Contact Fogarty Auction Service).
